Mount St. Joseph University offers students an opportunity to earn a master's degree and meet the requirements for an Ohio teaching license for those who wish to teach grades four through nine. Students focus on two concentrations from the areas of: language arts, mathematics, science, or social studies. Students will earn a Master of Arts degree – Major in Teaching and licensure in Middle Childhood Education.

### WHY THIS PROGRAM MAKES SENSE

You'll earn your master's degree and be eligible for middle childhood licensure (grades 4-9) in the state of Ohio. Through reciprocity agreements, you'll also be eligible for licensure in other states. Education classes are held in the evenings and on Saturdays to accommodate the schedules of working adults. Most of our courses include online and in-class components. Undergraduate courses from your bachelor's program may fulfill your two content areas. In some cases additional content courses may need to be taken. You will have hands-on classroom experience in both of your content areas, as well as a full semester of student teaching.

- Official college transcripts showing a cumulative GPA of no less than 3.0; a GPA below 3.0 requires completion of the GRE
