## ADMISSION CRITERIA

Applicants must submit:

- A completed graduate application at [www.msj.edu/apply](http://www.msj.edu/apply).
- A copy of current teaching license (only required for the Ohio Reading Endorsement).
- A letter of intent.
- A copy of your resumé.
- Contact information for two professional references.
- Official college transcripts showing a cumulative GPA of no less than 3.0; a GPA below 3.0 requires completion of the GRE.
- Acceptable criminal background check.

**May Cohorts:** Applications are accepted August 1st – March 1st

**August Cohorts:** Applications are accepted December 1st – June 1st

**January Cohorts:** Applications are accepted April 1st – October 1st

## READING SCIENCE PROGRAM OPTIONS

### Master of Arts Degree (MA) (33 credits)

MA degree students will complete the core set of courses and continue with 18 additional credit hours. Most students complete the MA degree in 6 semesters.

### Dyslexia Certificate (21 credits)

The Dyslexia Certificate is issued by the University. Students also meet requirements for the **IDA-CERI Dyslexia Interventionist Level 2 certification**. Most students complete the certificate in 4 semesters.

### Ohio Reading Endorsement (18 credits)

The Endorsement can be attached to any current Ohio teaching license. Most students complete the endorsement in 3 semesters.

### Reading Science Certificate (15 credits)

The Reading Science Certificate includes our core set of courses (15 credit hours) and addresses best practices in teaching reading. Students also meet requirements for the IDA-CERI Classroom Teacher Level 1 certification.

RDG 532 Advanced Phonics (7 weeks)

### Master's Degree: 33 credit hours

Five Core Reading Science courses plus:  
RDG 537 Data-Based Decision-Making II (7 weeks)  
RDG 532 Advanced Phonics (7 weeks)  
RDG 542 The Integration of Reading Comp. and Writing Instruction (7 weeks)  
RDG 592 Evidence-Based Practicum 2 Vocabulary and Comprehension (7 weeks)  
EDU 500 Research and Statistics (7 weeks)  
EDU 604 Integrative Research Project (16 weeks)

### Program plans may be combined.

In addition to completing the required coursework, students must join a professional organization, attend a professional conference (six hours), and pass the Knowledge and Practice Examination for Effective Reading Instruction (KPEERI) exam.
