It is available to all students at the Mount, not just students with business-related majors. Students with non-business majors meet the foundation requirements either by completing coursework for a minor in business administration (18 credit hours) or by completing academic leveling modules. Students apply during their junior year. Those admitted take four MBA courses their senior year and complete the remaining eight MBA courses in the fifth year.
