#### **PROGRAM FEATURES**

Mount St. Joseph University's Physician Assistant (PA) Program prepares students to become outstanding clinicians fully prepared to deliver quality health care in an ever-changing environment.

The 27-month, graduate degree program emphasizes critical thinking and life-long learning through its use of hands-on patient care and state-of-the-art technology.

#### FORMAT

The first year includes 12 months of classroom training including anatomy, physiology, pharmacology, clinical medicine, genetics, diagnostic lab, EKG, physical exam, and clinical skills. Second year students will complete clinical rotations in family medicine, internal medicine, general surgery, women's health, pediatrics, emergency medicine, orthopedics, and behavioral health, along with three student-selected elective rotations. Following the clinical phase, students complete a comprehensive summative evaluation.

### ADMISSION CRITERIA

#### Bachelor's degree from a regionally accredited institution with a minimum cumulative GPA of 3.0 and science GPA of 3.0.

Pre-requisite course work has to have been completed within 10 years of matriculation (at the start of the Program in January), except for Anatomy & Physiology I and II with lab, which needs to be completed within 5 years of matriculation.

#### Graduate Record Examination (GRE)

- The exam must have been taken within the last five years. CASPA GRE code 7328.
- If the applicant has taken the GRE multiple times, the admissions committee will super-score the GRE. This entails the use of the highest score from each section of the exam.

#### Central Application Service for Physician Assistants (CASPA) Submission

 The application cycle opens each year in April and can be accessed at: caspa.liaisoncas.com.

#### **Three letters of Recommendation**

- One letter from a physician assistant.
- One letter from a current or prior professor or supervisor.
- · One letter from another professional or social colleague.

#### **Health Care Experience**

- Minimum health care experience of 500 hours to include direct patient care (e.g. nurse aide, nursing assistant, medical assistant, EMT) which may be paid or voluntary in nature.
- Minimum of 40 hours shadowing a physician assistant in a clinical setting. **TOEFL iBT**

- Requirement for international students or those students who did not attend a high school where English is the primary language. Information can be accessed at www.ets.org/toefl.
- A minimum score of 120 is required with at least a score of 26 in each of the following categories: reading, listening, speaking, and writing.

- applicants who are: Graduates of Mount St. Joseph University.
- Veterans of the Armed Forces (In order to receive VA Educational Benefits, students must have their clinical rotations limited to Ohio hospitals that have been approved by the Veteran's Administration).
- Residents of Greater Cincinnati.
- Applicants with significant prior health care experience.
- Applicants with higher grade point average (GPA).
- Applicants with higher GRE scores.
- Applicants with higher number of hours shadowing a physician assistant.

No applicant who was dismissed from or discontinued their participation in a health professional program due to an academic deficiency, or non-academic policy violation(s), will be considered for admission.

There is no acceleration or advanced standing in the program regardless of prior experience or degree.
